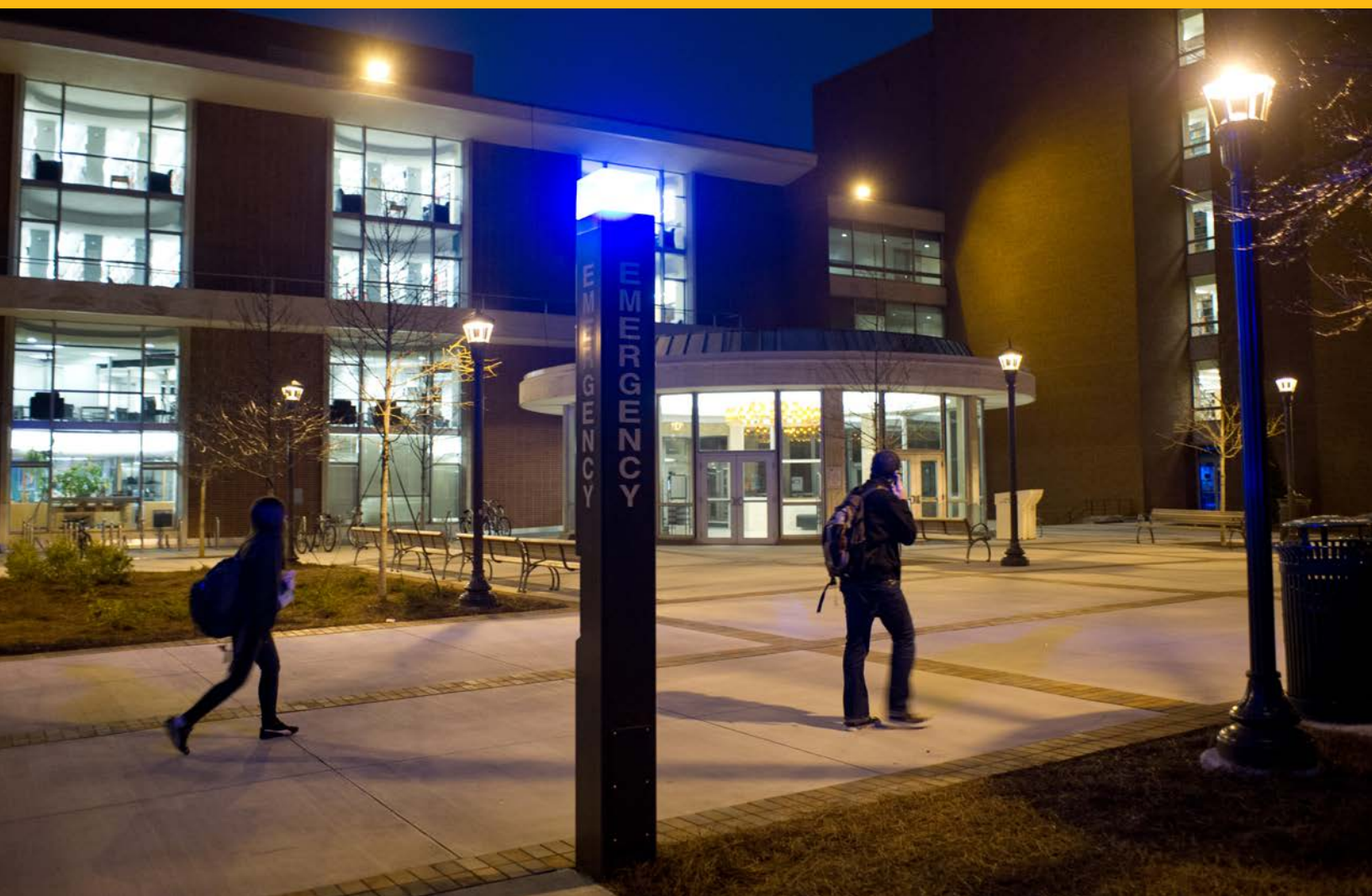

Campus Overview

The Georgia Institute of Technology is one of the nation's top research universities, distinguished by its commitment to improving the human condition through advanced science and technology. Georgia Tech's campus occupies 400 acres in the heart of the city of Atlanta, where more than 20,000 undergraduate and graduate students receive a focused, technologically based education.

Accredited by the Southern Association of Colleges and Schools (SACS), the Institute offers many nationally recognized, top-ranked programs. Undergraduate and graduate degrees are offered in the Colleges of Architecture, Business, Computing, Engineering, Sciences, and the Ivan Allen College of Liberal Arts. Georgia Tech is consistently ranked in *U.S. News & World Report's* top 10 public universities in the United States.

Georgia Tech is an open campus; access to the campus is not controlled. Except for residence halls, which are locked 24 hours a day, and some research areas, Institute facilities are open to the public during regular business hours. At other times, facilities are locked and only persons authorized by Space Planning, Facilities, or the individual departments within the building may have access.

Georgia Tech Facilities maintains Institute buildings and grounds with a concern for safety and security. Its staff regularly inspects the campus, evaluates lighting, and makes repairs to improve safety and security. The Georgia Tech Police Department (GTPD) and other departments assist Facilities by reporting potential safety and security hazards.

No campus is isolated from crime; therefore, Georgia Tech has taken responsibility to employ security measures to protect the campus community. All persons who come to campus are expected to obey all laws and Institute and department rules related to the use of each facility. Those who fail to comply are subject to arrest and/or disciplinary action through the Institute.

Campus Law Enforcement

Campus Law Enforcement Responsibilities

Primarily responsible for protecting the life and property of people on the Georgia Tech campus, officers patrol the campus on a 24-hour basis and provide a full range of public safety services including:

- Investigating criminal incidents and traffic accidents.
- Providing first response to emergencies.
- Enforcing laws and Institute regulations.
- Reporting crimes and traffic accidents.
- Conducting crime awareness and prevention programs.

When a criminal act is reported, the GTPD will investigate the incident and make every reasonable effort to identify the offender(s). Depending upon the wishes of the victim, nature of the offense, and the evidence



gathered, the case could be presented for prosecution in the criminal courts of Georgia.

If a member of the Georgia Tech community is identified as an offender in an incident, the GTPD will also notify the appropriate Institute administrator so that administrative disciplinary action may be taken.

Campus Law Enforcement Training

Officers are professionally trained and certified in accordance with the Georgia Peace Officer Standards and Training Council and attend continuing in-service training programs to further develop their skills.

Authority

State laws (O.C.G.A. 20-3-72) give GTPD officers the authority to make arrests for crimes committed on any property under the jurisdiction of the Board of Regents of the University System of Georgia and for



offenses committed on any public or private property within 500 yards of any property under the jurisdiction of the Board.

Additionally, the GTPD works closely with city, county, and state law enforcement agencies throughout Georgia. A memorandum of understanding between the GTPD and local law enforcement agencies is in place to facilitate effective collaboration on the investigation of criminal offenses.

LOCATION

The Georgia Tech Police Department (GTPD) is located at 879 Hemphill Avenue and is open 24 hours a day, seven days a week, including weekends, holidays, and semester breaks.



Procedures for Reporting Crimes and Other Emergencies

Accurate and Prompt Reporting: General Procedures

Like any other large community, Georgia Tech experiences accidents, injuries, crimes, and other emergencies and encourages prompt reporting of these incidents. To report such incidents, potential criminal actions, or suspicious persons, please call 911 from a campus phone or notify GTPD at 404.894.2500 or 404.894.GTPD. An officer will be dispatched to the scene and, if necessary, additional emergency assistance will be summoned.

Note: Confidentiality is limited to that provided by law.

Missing Student Policy Statement

If there is reason to believe that a student living in on-campus housing has been missing for 24 hours or more, the person who realizes that the student is missing must contact one of the following: the GTPD, the Housing Office, and/or the Office of the Dean of Students. Any campus official who is aware that a student living on campus has been, or may have been, missing for 24 hours or more must immediately notify the GTPD in person or by phone at 404.894.2500 or 404.894.GTPD.

Upon notification that a student is or may be missing, the GTPD will investigate to determine whether the student is, in fact, missing. If it is determined that a student is missing, the GTPD will notify the appropriate campus administrators (Dean of Students, Director of Housing, etc.) and the appropriate law enforcement agency within 24 hours after the investigation.

Students living in on-campus housing are encouraged to identify a confidential contact person or persons who will be notified by the Institute or by the Office of the Dean of Students within 24 hours if the student is determined to be missing. If the student is under the age of 18, and not emancipated, the Office of the Dean of Students will notify the student's custodial parent or legal guardian and the confidential contact

person within 24 hours after the student is determined to be missing. A student who wishes to identify a confidential contact can do so through OSCAR under the "Personal Information" menu. A student may view and update the "Housing Missing Person Contact" at any time.

All contact information collected for the purpose of locating missing students shall remain confidential, will be used only for the purpose specified herein, and will not be disclosed outside of the realm of a missing student investigation.

Reporting by Pastoral and Professional Counselors

Any incidents that may have been reported only to pastoral and professional counselors of the Institute are generally protected by privacy rights of the client or patient and are not disclosed in this document.

Suspected Child Abuse Reporting

Effective July 1, 2012, Georgia state law requires all Georgia Tech employees and volunteers who, in the course of their duties, suspect that a child has been abused on or off campus to report that abuse immediately. Suspected child abuse should be reported to GTPD in person or by phone at 404.894.2500 or 404.894.GTPD, and should also be reported to the employee or volunteer program director.

How to Report a Crime

To report a crime in progress, please call 911 from a campus phone. To report non-emergency-related crimes, please call 404.894.2500 or 404.894.GTPD from an on- or off-campus phone or cellphone. Dispatchers are available at these respective telephone numbers 24 hours a day. All GTPD reports are forwarded to the Office of the Dean of Students for review and for potential action by the Office of Student Integrity (OSI). GTPD investigators will examine a report when it is deemed appropriate. Additional information obtained via the investigation will also be forwarded to OSI.

Timely Warnings

In the event that a situation arises that, in the judgment of campus officials, constitutes an ongoing or continuing threat, the GTPD will issue a timely warning to the campus. GTPD also shares warnings from local police

departments if the campus area may be impacted. Such reporting is in compliance with the Clery Act, a federal statute enacted to keep students, faculty, and staff informed of criminal activity on or near campus.

GTPD will work with Institute Communications to distribute campuswide emails and post warnings online.

Anyone with information warranting a timely warning should report the circumstances to the GTPD by calling 404.894.2500, 404.894.GTPD, or 911—or by visiting the department office at 879 Hemphill Avenue.



Disclosures to Alleged Victims of Crimes of Violence or Non-Forcible Sexual Offenses

OSI will, upon written request, disclose to the alleged victim of a crime of violence or non-forcible sexual offense, the results of any disciplinary hearing conducted by the Institute against the student who is the alleged perpetrator of the crime or offense. If the alleged victim is deceased as a result of the crime or offense, OSI will provide the results of the disciplinary hearing to the victim's next of kin, if so requested.

Sexual Offenses

What to Do

No matter what risk reduction measures you take, you or someone you know may experience an unwanted sexual encounter. If this does occur, there are professionally trained individuals at Georgia Tech who can assist you. We recommend the following:

Seek Medical Attention

If an assault has just occurred, getting medical attention within the first 72 hours is important for medical reasons, as well as to collect evidence. Local rape crisis centers are available for medical and counseling assistance 24 hours a day. Call 404.616.4861 to contact Grady's Rape Crisis Center directly. Georgia Tech's Women's Clinic in Stamps Health Services is available during office hours for assistance and follow-up care. GTPD will make arrangements for medical attention. You may request that a friend or family member accompany you. Additionally, a staff member of the Office of the Dean of Students or an advocate from the Women's Resource Center can be contacted to accompany you to the hospital or to talk to you about available resources. The Women's Resource Center has an on-call advocate available to assist you 24 hours a day.

Although your first instinct after a sexual assault may be to bathe, it is very important that you do not bathe, wash, gargle, brush your hair, or change your clothes. Important evidence could be destroyed if you do so. If you do bathe, it is still important to seek medical care. If possible, bring your changed clothes in a brown paper bag for evidence collection.

Reporting Options

- A victim may meet with a staff member of the Women's Resource Center, which is a unit of the Office of the Dean of Students, to discuss support services and reporting options. At this time, the victim may prepare a statement regarding the assault.
- If the accused person is a student, the victim may file a report with OSI for investigation.
- If the accused person is a faculty or staff member, the victim may file a report with the Office of Human Resources for investigation.

AND/OR

- The victim may file an official report with GTPD or local police for a criminal investigation. Reports to GTPD will be shared with OSI and will be investigated for campus violations. The Women's Resource Center can provide an advocate to assist with reporting to campus or local police.

OR

- The victim may file a confidential report with the Office of the Dean of Students, Department of Health Promotion, Department of Housing professional staff, or the Women's Resource Center.
- Victims may choose a confidential reporting option where general information is collected for campus statistics but the case is not investigated.
- If information is provided that would identify the accused person, federal law requires the Institute to investigate the case. Examples of identifying information include but are not limited to: name, email address, apartment or room number, job title (e.g., TA for a particular class), and/or specific description.
- The victim does not have to file a report in order to receive support services.

The complaint should be submitted as soon as possible after the misconduct or harassment has occurred. However, OSI will review the allegation past the deadline stated in the Student Code of Conduct to determine if an investigation is feasible at the time the information is submitted to the office.



Consider Counseling

The Georgia Tech Counseling Center is committed to assisting students who have been sexually assaulted. The confidential services at the Counseling Center are free for enrolled students, and same-day appointments are available in emergency situations. To make an appointment at the Counseling Center, call 404.894.2575.

A 24-hour emergency consultation service is also available from the Counseling Center. You may contact an on-call counselor through the GTPD at 404.894.2500. You do not have to file a police report for counseling assistance. Aftercare in the form of counseling, advocacy, and follow-up is also available from local rape crisis centers.

Advocate Services

In addition to assistance from the GTPD, Grady's Rape Crisis Center, and the Georgia Tech Counseling Center, a staff member from the Women's Resource Center can serve as your advocate. An advocate can assist victims (male or female) in identifying resources to cope with the aftermath of sexual violence. These resources include counseling services, medical attention, concerns with housing, safety, or academic performance, etc. To contact the Women's Resource Center directly, call 404.385.0230.

Sexual Misconduct
Disciplinary
Procedures

Potential violations or individuals reported to GTPD will be investigated by OSI per the procedures found in the Student Code of Conduct. All rights of the victim/complainant and accused will be observed. Possible sanctions, as listed in the Student Code of Conduct, are as follows:

- Disciplinary Warning
- Disciplinary Probation
- Suspension Held in Abeyance
- Suspension
- Expulsion

Victim’s Bill of Rights

The federal 1992 Victim’s Bill of Rights assures victims of the following rights: (Adapted from Statute Text-20 USC § 1092 (f)(8))

- To have any and all sexual assaults committed against them treated with seriousness, dignity, and respect.
- To receive information outlining the campus procedures to follow once a sexual offense has occurred.
- To receive information about options to report a sexual assault (i.e., campus and/or local police, OSI, and the confidential reporting form) and assistance from trained advocates if requested.
- To have all the rights the accused has in the student conduct process. Rights include being informed of the date and location of a conduct hearing, having an advisor present during meetings and hearings, being informed of the outcome of any campus conduct proceedings alleging sexual misconduct or harassment, and exercising the right to appeal. If the alleged victim is deceased as a result of such crime or offense, the next of kin of such victim shall be treated as the alleged victim and notified of the process, procedures, and outcome of any disciplinary proceedings.
- To be notified of options and assistance in changing academic and living situations if the requested options are available. The Office of the Dean of Students, OSI, and, in particular, the Women’s Resource Center will work with students requesting these services.

- To receive support services (i.e., campus counseling and medical assistance) without being required to pursue legal or judicial cases.

Rights of the Accused

Throughout the conduct process, the accused is granted the following rights:

- To seek information from a student conduct administrator about the investigation and resolution process.
- To be informed of the charge(s) and alleged misconduct upon which the charge is based.
- To be informed of the information upon which a charge is based and afforded an opportunity to offer a relevant response.
- To be accompanied by an advisor of his or her choice.
- To be informed of the outcome of any institutional disciplinary proceedings.
- To remain silent with no inference of responsibility drawn.
- To call and question relevant witnesses.
- To present information on his/her behalf.
- To be considered not responsible until proven responsible by a preponderance of the evidence.
- To appeal the decision.
- To waive any of the above rights.

Federal Sex Crimes
Prevention Act

The Federal Campus Sex Crimes Prevention Act (section 1601 of Public Law 106-386), enacted on October 28, 2000, went into effect October 28, 2002. It is a law that provides for the tracking of convicted, registered sex offenders enrolled as students at institutions of higher education or those working or volunteering on campus. The law requires higher education institutions to issue a statement advising the campus community where state-provided law enforcement agency information concerning registered sex offenders may be obtained. It also instructs sex offenders, already required to register in a state, to provide notice to the appropriate state agency, as required under state law, of each institution of higher education in that state at which the person is employed, carries on a vocation, or is a student. This information is available through the Georgia Bureau of Investigation at www.gbi.georgia.gov.

Alcohol and Drug Policy Statement

Alcoholic Beverages

The Institute has established policies and guidelines governing the possession, sale, and consumption of alcoholic beverages on campus. A copy of the Student Alcohol Policy may be obtained through OSI. A copy of the Policy on Employee Alcohol and Illegal Drug Use may be obtained from the Office of Human Resources. Any use of alcoholic beverages on campus must be in compliance with the Georgia law prohibiting the use of alcohol by persons under the age of 21. Students of legal drinking age in Georgia may possess and consume alcoholic beverages in their private residences.

At any campus function for students where alcohol is served, campus officials must give approval and certain provisions must be made. Each person is legally responsible for his or her actions in all mental and physical conditions, including those induced by alcoholic beverages.

Illegal Drugs

Institute regulations prohibit the possession or use, without a valid prescription, of any substance currently classified as a dangerous drug by the Georgia Controlled Substance Act. Any individual breaking the law will be subject to disciplinary action and arrest.

Substance Abuse Education

Georgia Tech is committed to maintaining a campus free of drug and alcohol abuse and assisting all employees and students in finding ways to address such problems. Educational programs addressing these issues are supported and encouraged through a variety of departments. Anyone aware of substance abuse problems with roommates, friends, or coworkers is encouraged to contact the appropriate office for help.

Substance Abuse Assistance

For students with substance abuse problems, assistance is available through the Georgia Tech Counseling Center and the Department of Health Promotion. The Counseling Center has experienced professional counselors and psychologists to assist students in need.

Students are scheduled for individual appointments, and all information is kept strictly confidential. Health Promotion has a full-time substance abuse prevention coordinator and trained student peer educators available to provide information individually or in group settings. Students are also welcome to seek help through Health Services, located at 740 Ferst Drive. For more information, students are encouraged to contact one of the following centers:

Georgia Tech faculty and staff may obtain assistance through the Office of Human Resources Faculty and Staff Assistance Program at 404.894.1225. Alcohol and drug assistance programs are available, as well as referral to community agencies. Counseling and referral services are provided by appointment, and all information is kept strictly confidential. The Faculty and Staff Assistance Program also offers training and educational programs regarding drug and alcohol awareness.

Any use of alcoholic beverages on campus must be in compliance with the Georgia law prohibiting the use of alcohol by persons under the age of 21.



Security and Facilities Access

Living on Campus

Georgia Tech encourages its students who do not reside with their parents or families to live in the residence halls. The Housing Department supervises the assignment of rooms for single and married students. For a complete guide containing information about housing facilities and services, costs, priorities, policies, and residence hall safety, contact the Georgia Tech Housing Department at 404.894.2470.



Access to Residence Halls

Exterior doors of the residence halls are locked 24 hours a day. A resident accesses his or her assigned building with the student identification card, and his or her individual room with a key. A resident must escort all visitors through the residence halls. In the event of a lost key, the student's room locks are re-keyed.

Staff Training

All residence life staff members undergo thorough training in enforcing residence hall security policies. As part of their responsibility as residence hall security enforcers, all residence life staff members participate in lectures and seminars associated with the safety and security of the campus.

Living in Off-Campus Housing, Fraternities, and Sororities

Neither the Housing Department nor Georgia Tech provides supervision for off-campus housing, apartments, or individual homes. Sororities and fraternities educate their members on safety and security in their houses and on campus. All students receive crime awareness information. Students, whether they live on or off campus, are encouraged to report all crimes to the appropriate police agency.

Campus Safety Resources and Services

How You Can Help Create a Safe Campus

Safety, security, and crime prevention are everyone's responsibilities. The cooperation and involvement of faculty, staff, and students are absolutely essential to having a safe campus. The safety and the security of you and your belongings begin with your own awareness and commitment to the safety of the community. During orientation in the fall, spring, and summer, all members of the campus community are informed of crime prevention and safety awareness programs offered by the GTPD. Crime prevention programs and sexual assault programs are offered on a continual basis.

Note: While Atlanta police have primary jurisdiction in all areas off campus, GTPD officers work with local, state, and federal law enforcement units to respond and assist with student-related incidents or offenses that occur in close proximity to the campus.

How to Stay Informed

The GTPD uses a variety of methods to keep the campus informed about incidents occurring on and near campus.

- *Technique* and *The Whistle*: student and faculty/staff newspapers.



- Georgia Tech Emergency Notification System (GTENS): Launched in 2007, GTENS is a communications system that allows urgent messages to be distributed to students, faculty, and staff in the form of email, voice mail, and text messages in a matter of minutes. Georgia Tech's system will also post messages on the Emergency Preparedness Facebook and Twitter pages, and on many of the TV monitors on campus. Participation in GTENS is optional, but strongly encouraged.
- Hazardous weather alerts: Georgia Tech community members may subscribe to hazardous weather alerts and access information about adverse weather conditions at www.police.gatech.edu/weather.htm.





Other Resources and Services

A variety of resources and services that contribute to overall campus safety and security are available to Georgia Tech students, faculty, staff, and visitors.

- **Jacket Guardian:** This is a free opt-in system that transforms mobile phones into personal safety devices, enabling the GTPD and any Smart911 center to instantly access a user's profile information in an emergency. With Jacket Guardian's timer feature, users can also inform the GTPD of their intended destinations, specifying the expected time of arrival; police will receive an alert if the timer expires. - **Publications:** The GTPD prepares and distributes numerous brochures and pamphlets covering topics such as rape awareness, general crime prevention, harassing phone calls, bicycle safety and security, and traffic safety. Copies are available at the GTPD office.

- **New Student and Employee Orientations:** New students are provided with crime awareness information through the FASET (Familiarization and Adaptation to the Surroundings and Environs of Tech) program. New employees receive information through the New Employee Orientation Program.

- **Emergency/Public Telephones:** For the safety of the Georgia Tech community, more than 200 emergency/public telephones are strategically located across campus. These telephones may be used to make campus calls. For emergency situations, press the red emergency button, which will connect you directly with the GTPD. Your location will be automatically identified for the police dispatcher, and a GTPD officer will be dispatched to the area if necessary.

- **Crime Prevention 101:** This course is offered to students, faculty, and staff.

- **Self-Defense Training:** The GTPD coordinates self-defense training and crime prevention techniques with the Campus Recreation Center.

- **Campus Transportation:** Georgia Tech has a bus service, the Stinger, and a nighttime van escort service, the Stingerette, available when the Institute is

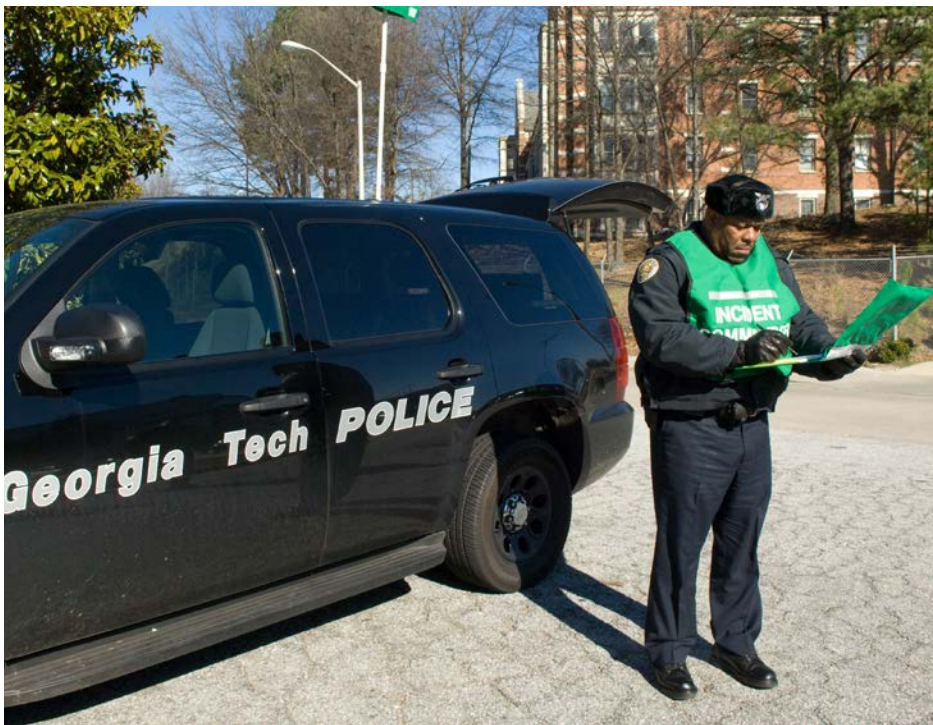
in session. For more information, including operating hours, contact Parking & Transportation Services at 404.894.9645.

- **Laptop Registration:** This program assists members of the Georgia Tech community in marking and tracking information (serial and model numbers, etc.) for valuable items such as calculators, computers, and televisions. Engravers for marking valuables are available, and participants are provided with inventory cards. Register online at www.police.gatech.edu/services or call 404.385.3346 or 404.894.1288 for more information.
- **Bicycle Registration:** Members of the Georgia Tech community who bring bicycles to campus are encouraged to register their bicycles for free with the GTPD. Bicycle owners provide the department with important identification information about their bicycles and receive a registration sticker to place on their bicycles. Bicycles can be registered at www.police.gatech.edu/services. Call 404.385.3346 or 404.894.1288 for more information.
- **Security Surveys:** Free security surveys are offered by the GTPD for campus buildings and on-campus residents. For more information, call 404.894.1284.
- **Lost and Found:** The GTPD operates a lost and found area. You can stop by the GTPD to drop off found property or inquire about lost property. Lost property may be reported at www.police.gatech.edu/lostandfound.
- **Crime Awareness and Prevention Speakers:** You can request a speaker from the GTPD to come and talk with your group or organization about crime awareness and prevention. To request a speaker, call 404.385.3346 or 404.894.1288.

Emergency Response and Evacuation Procedures

In a major emergency, the decision to implement campuswide evacuation procedures generally rests with the president and his advisory group. In situations requiring immediate action, public safety responders (police, fire, environmental health and safety) can also order an evacuation. When evaluating the possible evacuation, consideration will be given to the specific threat, its context, and the recommendation of the public safety officials. Evacuation and notification procedures are published annually in the Georgia Tech Emergency Action Plan

and are available to the public at **www.emergencypreparedness.gatech.edu**.

Georgia Tech employs several systems for emergency notification, including GTENS, the outdoor Siren Warning System, social media, the Institute website, the campus cable network, and the campus radio station.

GTENS is the primary method of emergency notification. GTENS alerts are designed to be sent without delay to the campus community when there is a need for the receivers to take immediate action. As

stated in the GTENS Standard Operating Procedures, the decision to send out an emergency alert is based on the need for the receiver of the message to take immediate action. The authority to send a GTENS alert is as follows:

- The executive vice president of Administration and Finance, chief of police, deputy chief of police, emergency preparedness director, emergency preparedness project manager, and GTPD captains have the authority to alert campus. After hours, this decision will often be made at the command post and after approval from the patrol captain.
- AccuWeather automatically processes GTENS tornado warnings.
- Active shooter alerts can be sent out under the watch commander's authority.

Once public safety officials have confirmed the emergency situation and the appropriate authorization has been obtained, the content of the message is created and the alert is sent. Georgia Tech maintains three pre-drafted messages within GTENS to ensure rapid alerts for the most commonly occurring emergency situations, such as tornado warnings. Georgia Tech conducts a test of all notification systems, including GTENS, three times a year: once in the fall, spring, and summer. The outdoor siren warning system is tested the first Thursday of every month. Georgia Tech has an aggressive exercise program that tests emergency response procedures, and emergency notification is included in most drills and exercises.



Personal Safety Tips

By taking a few simple precautions as you go about your daily activities, you can reduce your chances of becoming a crime victim.

Basic Rules

- Be aware of your surroundings; stay alert and do not get distracted.
- Choose well-lit, busy streets and areas, and walk with a friend.
- Know where the police station is and which buildings are open late.
- Use body language to communicate that you are calm, confident, and know where you are going.
- Make eye contact with those around you and walk tall.
- Trust your instincts. Leave if you feel uncomfortable in a setting.
- To escape danger, cross the street, move to a well-lit area, and quickly go to the nearest house or open facility.
- Never prop open exterior doors to residence halls or other buildings.
- Keep room doors locked at all times.
- Carry your keys at all times.

Publicizing Personal Information

- You are cautioned against publicizing personal information—your name, picture, hobbies, and other detailed personal information—on websites and other easily accessible sources.
- When you publicize personal information, you open the door for this information to be used by individuals to commit identity theft and/or other predatory crimes.



When Walking

- Walk facing traffic.
- Carry a minimal number of belongings.
- Keep emergency money for telephone calls and/or transportation.
- Have your keys in your hand when approaching your vehicle or residence.
- If you feel you are being followed by someone in a vehicle, change your direction and write down the license plate number.

In a Vehicle

- Keep your vehicle in good running condition and filled with fuel.
- Plan your route in advance.
- Keep your vehicle doors locked at all times.
- Park in well-lit areas.
- If your vehicle breaks down, raise the hood, use flares, or tie a white cloth to the door handle. Stay inside the vehicle and keep all the doors locked and windows rolled up until help arrives.
- Never pick up strangers. Do not stop to help motorists; signal that you will call for help.
- If you are being followed, go to the nearest police or fire station, residence hall, or open facility. If no safe areas are near, honk the horn repeatedly and turn on your emergency flashers.

Jogging, Bicycling, and Other Outdoor Activities

- Choose safe, well-populated routes.
- Vary your routine, including the times you perform certain activities and the routes you take to or from such activities.
- Wear light, brightly colored clothing, especially at dusk and at night.
- Avoid jogging, biking, and other outdoor activities alone at night.
- If possible, carry a personal safety alarm.
- Do not wear headphones.

What If It Happens to You?

- Do not resist if the attacker is only after your purse or other valuables. Do not escalate a property crime into a violent confrontation.
- Remain calm and do not show signs of panic, anger, or confusion.
- Call the police immediately. Identify yourself and your location.
- Try to get a good description of your attacker, focusing on attributes such as:
 - Age
 - Sex
 - Scars
 - Race
 - Height
 - Tattoos
 - Weight
 - Complexion
 - Type of clothing
 - Body build

Property Safety Tips

The most frequently reported crimes are those involving theft of personal or institutional property. The following are some of the most frequent targets of theft reported to the GTPD and some security tips to help you protect your property.

Vehicles

- Always lock your vehicle, and do not leave the keys inside it.
- Remove all valuable items from your vehicle, including GPS devices and their mounts, clothing, electronics, purses, wallets, and change. Store valuables out of sight in your trunk if they must remain in your vehicle.
- Close all windows, and make sure the trunk and all doors are secured.
- Do not leave your vehicle registration and important identification papers inside your vehicle.
- Keep your vehicle's tag number, vehicle identification number (VIN), and a complete description of your vehicle in your wallet or a safe place at your residence.
- Remove electronic devices, their mounts, and chargers from your vehicle.

- Park in well-lit, busy areas, and do not leave your vehicle in unattended lots for long time frames.
- Install a security device, such as a steering column lock or a cut-off switch, that interrupts fuel or ignition systems.
- Secure your vehicle's license plate with tamper-proof bolts.

Bicycles

- Park your bicycle in areas with a high volume of pedestrian traffic.
- Lock your bicycle with a U-shaped lock.
- Engrave your bicycle with an owner identification number.
- Register your bicycle for free with the GTPD. A record will be made of the make, model, manufacturer's serial number, and the owner identification number.

Computers and Other Office Equipment

- Lock your room or office every time you leave.
- Keep records of your equipment including a description of the equipment along with the make, model, and manufacturer's serial number.

- Engrave or apply an owner or departmental identification marking where possible.
- Secure computers with cable locks or other security devices.
- Install burglar alarms capable of being monitored by the GTPD in computer labs, offices, or storage areas that contain large quantities of valuable office or research equipment.
- Consider purchasing and installing a tracking device on your laptop.
- Remember, free security surveys are offered by the GTPD for campus buildings and on-campus residents.

Textbooks and Thefts from Lockers

- Write your name or owner identification number on several pages inside your books.
- Never leave your book bag or books unattended at the library, dining halls, classrooms, lounge areas, or Campus Recreation Center.
- While lockers are safe places to store clothes, they can be broken into. Do not store valuable items in a locker without using a lock.





Preparing the Annual Security Report Crime Statistics

Major crimes reported to the GTPD for January through December of the most recent three-year period are listed below. Georgia Tech Police Incident Reports are subject to Georgia's Uniform Crime Reporting Program and the Georgia Open Records Act. Confidentiality is limited to only that provided by law.

The Campus Safety Report is prepared in cooperation with the local law enforcement agencies surrounding Georgia Tech's main campus, Office of Student Integrity,

Women's Resource Center, Housing and Residence Life, and Athletics. Each entity provides updated information on its educational efforts and programs to meet compliance requirements.

Disciplinary referrals for violations of the Student Code of Conduct, which may include some criminal offenses specified for this report, are sometimes made directly to the Office of the Dean of Students by individuals or campus organizations other than the GTPD. The statistics for Campus

Security Authorities come from the Office of the Dean of Students and Housing.

Email notification of the availability of the Campus Safety Report is sent out electronically to faculty, staff, and students before the October 1 deadline. Hard copies of the report may be printed from the GTPD website or picked up directly from the department. The report is located at www.police.gatech.edu/documents/brochure.pdf.

IMPORTANT INFORMATION

For the purposes of classifying reported crimes, the following definitions apply:

- Campus: (1) Any building or property owned or controlled by an institution within the same reasonably contiguous geographic area and used by the institution in direct support of, or in a manner related to, the institution's educational purposes, including residence halls; and (2) any building or property that is within or reasonably contiguous to the area identified in paragraph (1) of this definition, that is owned by the institution but controlled by another person, is frequently used by students, and supports institutional purposes (such as a food or other retail vendor).

- Non-campus building or property: (1) Any building or property owned or controlled by a student organization that is officially recognized by the Institute, such as Greek housing; or (2) any building or property owned or controlled by an institution that is used in direct support of, or in relation to, the Institute's educational purposes, is frequently used by students, and is not within the same reasonably contiguous geographic area of the institution.
- Public property: All public property, including thoroughfares, streets, sidewalks, and parking facilities, that is within the campus, or immediately adjacent to and accessible from the campus.

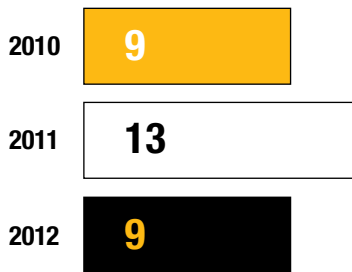

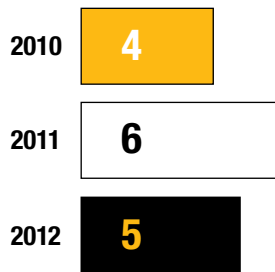

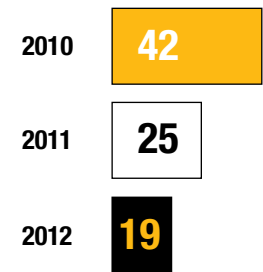

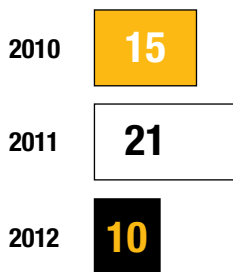

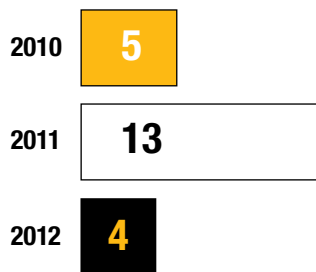

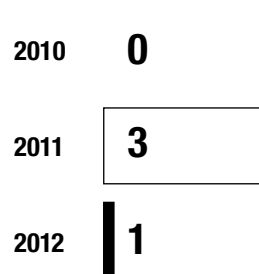

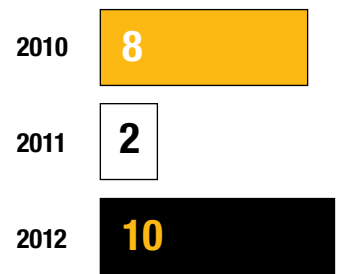

FIRE SAFETY REPORT



Annual Student Housing Fire Safety Report in Accordance with the Higher Education Opportunity Act (PL 110-315)

Georgia Tech's fire safety policy and rules are intended to prevent fires and fire-related injuries and/or deaths from occurring or affecting the Georgia Tech community and facilities. All Georgia Tech buildings are inspected annually, and residential rooms are inspected periodically, at random times during the year, to ensure compliance with state fire codes. Because of the seriousness of the consequences that could result from failure to comply with codes and Georgia Tech's fire safety rules, Georgia Tech takes disciplinary action on the first offense. This may include the imposition of a fine by the Housing Department. The Institute also has the right to require students who violate safety rules to vacate their accommodations — without financial credit for the remainder of the semester.

Fire Safety Standards

Prohibited Behaviors in Georgia Tech Residential Facilities

- Misusing or tampering with fire-safety equipment. This includes, but is not limited to, fire extinguishers, hoses, horns, bells, conduit sections, alarm-pull trigger devices, fire sprinklers, central-relay control bases, and glass covers for fire extinguishers, as well as pulling false alarms.
- Obstructing hallways, sidewalks, or stairwells that might impede evacuation from a building during an emergency.
- Propping open interior fire doors in common areas, stairwells, and hallways. Those are in place for added fire protection to slow the spread of fire.
- Storing bicycles in stairwells or any other location that might impede evacuation from a building during an emergency.
- Possessing chemicals or substances that are potentially dangerous or highly flammable. This includes, but is not limited, to gasoline, propane, lighter fluid, torches, etc.
- Leaving food cooking unattended.
- Failing to vacate the building when the fire alarm system is activated.

Open Flames

- Candles, incense burners, and other open flame devices are strictly prohibited.
- Using items that are potentially dangerous and/or flammable, including fireworks, hazardous materials, etc., is also prohibited.

Smoking

- Smoking is prohibited in all residence hall areas (rooms, apartments, suites, common areas, lobbies, lounges, stairwells, elevators, activity/recreation rooms, bathrooms, etc.). Those who choose to smoke must do so at least 25 feet from any residence hall.

Fire Safety Inspections

The Georgia Tech Fire Safety Office conducts yearly fire inspections in the residence halls within the first month of each semester, checking rooms for fire or unusual safety hazards and to ensure compliance with the following:

- No halogen-touchar lights. The intense heat generated by these bulbs creates a fire hazard and a potential source of burns. These bulbs start fires if they come in contact with curtains, clothes, paper, and other flammables. In addition, the lamps are unstable and can be easily tipped over.
- No overloaded electrical circuits. There can be only one major appliance (such as a refrigerator, TV, computer, microwave, etc.) per receptacle plug.
- No hanging of items from overhead lights, sprinkler heads, or pipes. No attachments to the ceiling.
- Immediate and proper disposal of appliances with old or damaged cords.
- Use of electrical appliances that meet the Underwriter's Laboratory (UL) or Electrical Testing Labs (ETL) safety standards.
- No removal of grounding pins from three-pronged electrical cords.
- No unattended operating of coffee makers and other appliances with exposed heating elements. They must be unplugged after each use and stored appropriately.
- No running of cords under carpet. Avoid stapling or tacking electrical wires to fixtures (on walls, over doorways, on ceilings, etc.).
- No open-element hot plates.
- Appliances and other higher wattage equipment should be plugged directly into a wall outlet.

Regular Mandatory Supervised Fire Drills

Georgia Tech's Housing Department, in conjunction with the Georgia Tech Fire Safety Office and the Georgia Tech Police Department (GTPD), conducts a total of 126 emergency evacuation drills per year. These drills are conducted within 10 days of the beginning of classes each semester. During fire evacuation drills, each fire alarm system in each on-campus student housing facility is activated. Once the alarm has been activated, students and visitors must exit immediately and gather at the designated evacuation safe refuge location. A sweep of all floors and a head count is conducted by a Housing Department representative and GTPD officer. Only when the alarm is silenced and the GTPD or local authority gives the "all clear," will reentry into the building be permitted. Students who do not vacate the building when a fire alarm is activated may be subject to judicial action.

Note: For these drills only, the fire alarm system is reset by the Georgia Tech Housing Electrical Department.

Fire Protection Systems

Fire Alarm Systems/Initiation and Pull Stations

Fire alarm pull stations are generally located at exit doors, stairways, and at elevators in Georgia Tech residential facilities. Once the alarm is activated, the Georgia Tech Police Communications Center automatically receives the signal and responds by contacting Atlanta Fire Rescue.

Smoke Detection

Smoke detectors are located throughout each floor of every residential facility on campus. If smoke is detected, the fire alarm system will automatically send a signal to the central station monitor.

Sprinkler System

The rise of temperature associated with fire in an area will activate the sprinkler system and send an alarm signal to the central station monitor. Currently, 78.3 percent of Georgia Tech housing beds are covered by sprinkler protection. Future renovation project plans will accomplish 100 percent sprinkler coverage by 2020 or sooner.

Sprinkler heads must not be tampered with or used as a means to hang personal items. This could cause malfunctioning of the system or substantial water damage if one of the heads accidentally discharges. These sprinklers disperse 20 to 40 gallons of water per minute. Georgia Tech is not responsible for any loss a student may incur as a result of tampering with sprinkler heads. A resident who knowingly or accidentally causes a sprinkler to activate may be charged for the repairs/cleanup and may be subject to judicial proceedings.

Note: It is against federal and state laws to tamper with or interfere with life and safety equipment. Destroying fire exit signs, fire alarm boxes, and other safety items could lead to disciplinary action, and the resident may be charged for the repairs/cleanup.

General Procedures

If smoke or a fire is discovered, the fire alarm must be activated immediately. Exit through the nearest door or stairway and proceed to the designated safe refuge area. If the nearest exit or exit stairwell is obstructed by smoke, fire, or other hazards, proceed to an alternate exit or exit stairwell. **Do not use elevators.**

Once assembled outside at the Emergency Evacuation Assembly Point, Housing PLs and RAs will account for all occupants and communicate with first responders if anyone is not accounted for and provide other information vital to safety and rescue.

Building occupants shall not reenter the building until the Authority Having Jurisdiction gives the "all clear."

Reporting Fires

To report a fire, students, employees, or visitors should call the Georgia Tech Police Communications Center at 911 from any campus landline. Alternatively, callers can dial 404.894.2500 from a cellphone. Either option will ensure the quickest response and will also ensure that other Georgia Tech personnel, as appropriate, are notified.

Training

Fire Safety Education and training programs are available for students, faculty, and staff. The Housing Department Student Staff Members (SSMs) receive classroom and/or hands-on training in the following areas:

- Fire extinguisher use
- Evacuation and emergency preparedness
- Kitchen fire safety
- Life safety systems
- Georgia Tech Fire Safety Rules
- Fire Inspection program

Planned Renovations and Upgrades

Georgia Tech aggressively upgrades fire alarm systems, fire sprinkler systems, and other egress-related components as needed and during building renovations. Whenever possible, upgrades are performed outside the set renovation schedule to update older systems.
