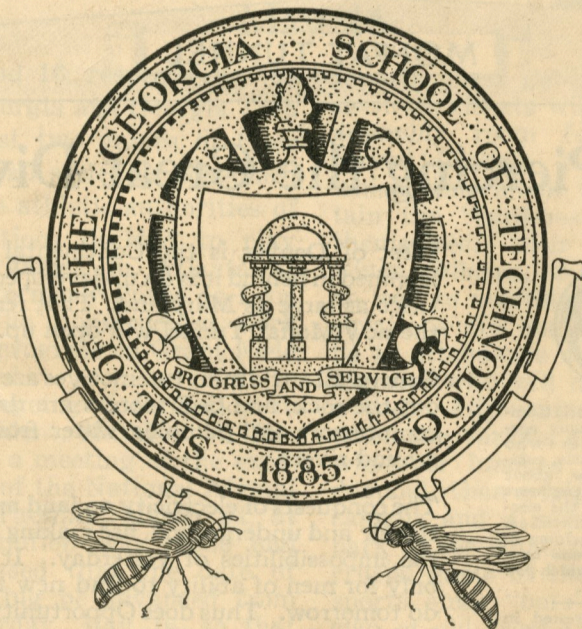

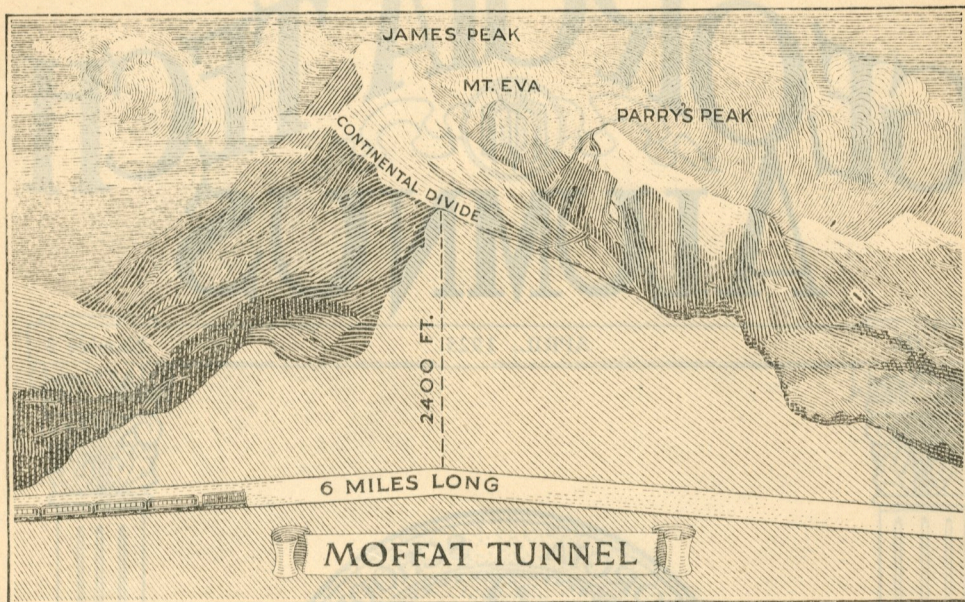

## Annual Meeting and Class Reunions Saturday, May 16

On May 15 and 16, respectively, the University of Georgia and Georgia Tech will play the last two games of their four game baseball series as scheduled this spring. The athletic authorities of the two institutions decided to play the concluding games in Atlanta at Spiller's Field—formerly Ponce de Leon Park—due to the construction work which will be in progress on Grant Field at the time stated.

With the foregoing information in mind, your President, Mr. Geo. W. McCarty, Jr., called a meeting of the executive committee of the National Alumni Association on Tuesday, March 24, at which time a motion was made and unanimously passed that the date of the annual meeting be advanced from June 8, to Saturday, May 16, so that all of you who will journey to Atlanta for the game may at the same time take part in the proceedings which will partake somewhat of the nature of an old time spirit meeting.

To make it convenient for the large number of you who will be down town on Saturday it was thought best to hold the meeting at 11 a. m., in the general assembly room of the Atlanta Chamber of Commerce, corner of Pryor St., and Auburn Ave. After the annual

reports, class get-togethers, and spirit sessions, tickets will be available in the assembly room for the specially reserved Georgia Tech Alumni box, at which time all of the alumni may obtain the "card-boards" necessary for themselves, their fathers, mothers, wives, children, or "fair dates." It may be well to mention here that these reservations are made for those who will be in attendance at the annual gathering and who will meet at the game in a body. Adjournment will be at noon when the various groups will "take on" whatever lunches their appetites will demand; then a trip of inspection to the campus and a re-assembly at the ball park to see what, no doubt, will be the crucial game of the first of the major sports since "befo' de war" with the clan of old from the classic city.

On behalf of the Athletic Association, Professor A. H. Armstrong has kindly offered complimentary tickets to all of the members of the class of 1900 who will hold their quarter-centennial reunion this year. Other classes scheduled to hold their reunions are: 1905, 1910, 1915 and 1920.

We are offering you an interesting time this year, alumni, and this is your open invitation to join hands with all of us and your own class-mates on



May 16. **This means everybody;** so take off the week-end or sign those letters before 11 o'clock on the morning of "the day;" attend the meeting, get the spirit and remember—you will see one of the best ball games played by one of the best teams that Tech has put out since the Knight and Day battery,

## Tech To Have ~~First~~ "Dad's Day" On May 16

An added attraction for the classes holding reunions, and, in fact, for all of the other alumni in Atlanta at the time, will be the celebration of Georgia Tech's first "Dad's Day" on May 16th.

In accordance with the present plans of the Student Council, the fathers of all Tech men will be invited by a joint committee of the faculty and Student Council, and every effort will be made to get a large number of them up for the occasion. The date selected is the day of the last baseball game with the University of Georgia, and as this game will be played in Atlanta, it should prove a great attraction in getting the fathers to Atlanta for the day.

A mass meeting of the student body and the fathers has been scheduled for the morning of "Dad's Day," at an hour preceding or following the alumni meeting so that the two may merge into each other. At this time, prominent men, chosen from the fathers, faculty, alumni and student body will speak to the gathering, after which the visitors will be

taken on an inspection tour of the college buildings and grounds. In the afternoon the main attraction will be the baseball game. The present plans are not final and may be revised, but the date will not be changed.

Scroop Enloe, varsity baseball pitcher, and a member of the Council's committee on "Dad's Day," was chosen to speak for the student body at the mass meeting.

At the same meeting it was voted to send a delegate from Tech to the annual convention of the Southern Federation of College Students which is to be held at the University of Florida on April 24 and 25. Carter Barron, popular junior representative on the Council was elected to represent Tech at the meeting of this organization which had its inception at Tech in 1923, when Albert Staton, then president of the Tech Student Council, invited representatives from the larger Southern colleges to Atlanta for the purpose of establishing a sort of intercollegiate forum.

## Nationally Known Tech Artist Features Annual

One of the features of the 1925 Blue Print will be the frontispiece that E. M. Jackson, B. S. in Architecture 1916, who is now a very successful artist, has kindly consented to do. Everyone is familiar with the work of Mr. Jackson, since his drawings appear frequently on the covers of the Saturday Evening Post, the Literary Digest, and other leading publications of the nation. While Mr. Jackson was at Tech he was Art

Editor of the Blue Print and did much to raise the art work of the Blue Print to its present high quality.

The subject that Mr. Jackson has selected for his drawing is "American Youth Using Knowledge to Guard Civilization." After the plates are made from this drawing it will be shipped to Atlanta, where it will be exhibited for a short time along with the other art work that is going in the book this year.



## Jacket Nine Makes Clean Sweep of Clemson and Furman Series in Order

The Jacket nine made a most successful debut into the 1925 season during the week-end of March 20 and 21 by a double win over the Clemson Tigers.

In the first game the Jackets scored a 4 to 0 shut-out victory. Scroop Enloe, who rose to no hit fame last season, showed that the old arm still is in fine shape. Enloe allowed just three hits in the entire game, which is nothing short of an achievement for an opening game against a team like Clemson.

This game argued well for the Techmen. They showed stuff. The hitting of Wycoff, Angley, and Merkel was exceptional. The three of them accounted for all of Tech's scores. The entire team registered eight hits, among them were two doubles and a triple. In addition to showing pitching strength and a keen ability to wield the bat, the Jackets snapped through two double plays that showed their ability at shooting the ball around for points.

All through the game Enloe had the Tigers at his mercy. Not a ball was batted to the outfield, and he forced six of the opposing team to whiff the ozone.

The second game of the series was also a shut-out affair in favor of Tech. The masterful pitching of Johnny Conn, and heavy hitting of the whole nine proved too much for the Tigers and Tech won 6 to 0.

Six Clemson players were retired by the strike-out route, while Martin was able to whiff only one Jacket. Conn's teammates played errorless ball behind him and this did much to help the situation. Silo Jones led the Jackets with the willow, as he secured two safe hits out of five trips to the plate. His long drive to center field is the longest hit that has been made this season.

Skinny Denicke also made two clean singles out of five tries.

For Clemson, Martin pitched a very creditable game of ball, but the inability

of his teammates to hit proved his undoing.

On Friday and Saturday, March 27 and 28, the Hurricane from Furman blew into Grant Field with a cold breeze and flushed from a two-game victory over Georgia; unfortunately for the Purple Hurricane, however, for they "blew up" against a swatting Golden Tornado to the count of 12 to 2 on Friday and similarly on Saturday, on the reverse side of a 12 to 3 score.

The first game started off in a reasonably sane manner but in their half of the second inning the Jackets decided they needed warming, and proceeded forthwith to garner eight runs from the deliveries of three of their opponents' pitchers.

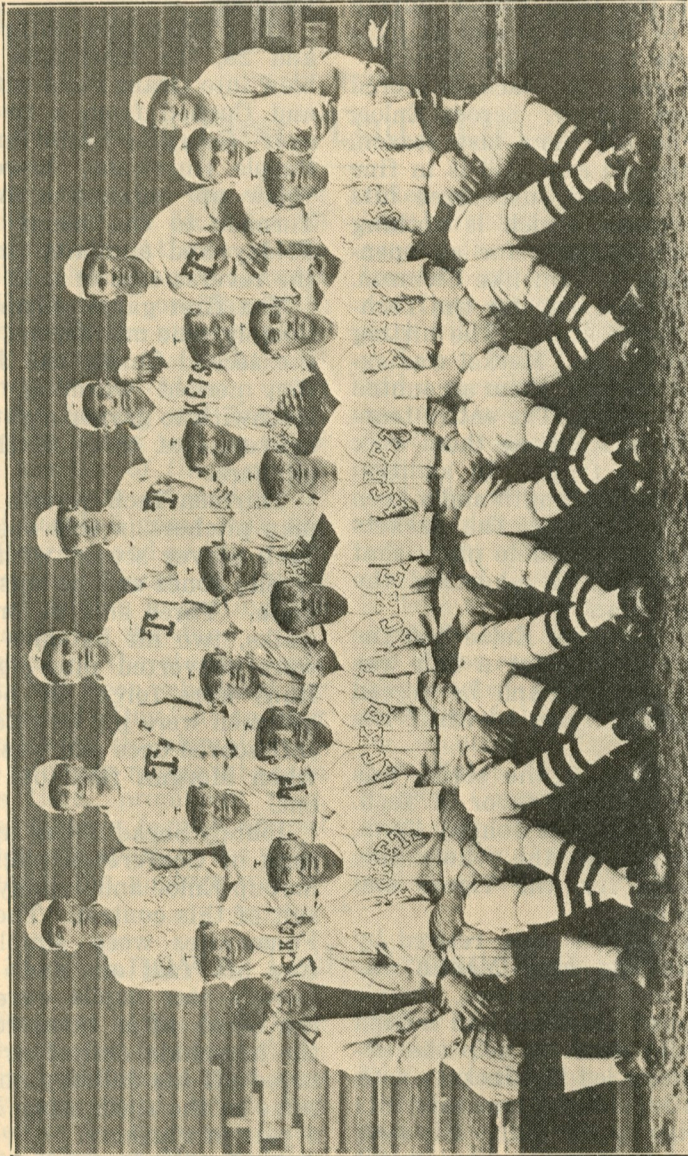
Thirteen Tech batters faced the Furman pitchers in this one inning. Every Tech player scored with the exception of Silo Jones and he was cut out at the plate. Three singles, one double, four walks, two hit batsmen and one error were converted into eight Tech runs. Runs were forced in both times that batsmen were hit by pitched balls. Wycoff scored once and was on third again when Morgan flied out for the third out.

Johnny Snead moved up into the front rank of Conference pitchers, alongside Scroop Enloe and Johnny Conn, as a result of this contest. The heavy hitting Furmanites were simply helpless before his fast one and seven of Billy Laval's star pupils were sent back to the bench after three futile swings at the horsehide. Only four hits were garnered off his delivery and two of these came in the sixth when Furman scored a pair of chalkers.

Angley led the hitters with one home run and three singles out of five trips to the plate; his circuit drive to the new east stands was one of the longest balls ever hit on Grant Field, it was still on the rise when it struck the top of the

stands. Denicke, Wycoff and Snead followed Tom with two hits each.

In the second encounter Kid Clay's sluggers worked Furman's star pitcher, Minnick, for eight hits and a resultant score of 12-3.

On the other hand Furman was helpless before the speed and control of the veteran right-hander, Scroup Enloe, and did not score until the seventh when the Jackets eased up a bit. Scroup struck out seven Furman players and gave but two free passes.

Captain Joe Palmisano caught a beautiful game of ball and not a single Fur-

man player attempted to steal a base. Joe's hitting was the feature of the game as he connected for two doubles and a single out of five trips to the plate.

Wycoff again annexed two hits, following Capt. Joe., while Denicke, Morgan and Angley hit for one each. Tom Angley, however, Babe Ruthed his swat for the circuit with Jones on second.

Don't judge that Furman has a slow ball club, far from it, their games with the Georgia Bulldogs showed more the type of ball they usually play and Georgia has a real club.

## Coach Griffin To Leave Tech

"George Griffin, for the past four years varsity track coach at Georgia Tech and former Jacket sprinter, has accepted a position as director of athletics and a professor of mathematics and physical education at the South He will report there September 1.

Georgia A. and M. college at Tifton, Ga.

"Griffin was one of the most popular students ever to graduate from Tech and he has a host of friends throughout the south. He accepted the position of varsity track coach in 1920 and has done much to raise the standard of track athletics in the south.

"It was he and Coach Alexander that originated the idea of the Southern Relay Carnivals and it was mainly through their efforts that the relays are now recognized as one of the premier athletic events of the southland. Griffin is chairman of the games committee and has virtual control of the managing of these games.

"The first freshman football team ever turned out at Tech was coached by George and it was one of the best as he imbued it with his own fighting spirit. Practically every member of that freshman team of 1920 later made his varsity letter. Last fall he and Tally Johnson were chief aides to Kid Clay in handling the yearling team and those that saw this team in action will attest to its football ability.

"During his college days George was one of the best sprinters in the south and still holds the Tech record of ten seconds for the 100-yard dash in conjunction with three others. Griffin also made his letter in football despite the fact he hardly weighed 130 pounds. He scrubbed for four years and it was his lack of weight that kept him from winning a regular berth.

"Tifton is unusually fortunate in securing such a man as Griffin and Tech will certainly lose a good man, both athletically and morally. Just who will take his place has not yet been decided and probably will not until later in the season. Track work will continue for the remainder of the season under his direction, however."—Atlanta Journal.

That's the story, men, as announced to the papers from the school. We can add but little more except that George deserves all the praise possible, as a clean man, a clean coach and athlete, and a great leader, one eminently qualified to direct and mould the lives of our young manhood.

George's resignation comes in the form of a promotion in recognition of his ability and his sterling characteristics. The good wishes of all the alumni go with him and while he betters his position, old Georgia Tech will always miss him. Lots of luck, old fellow.

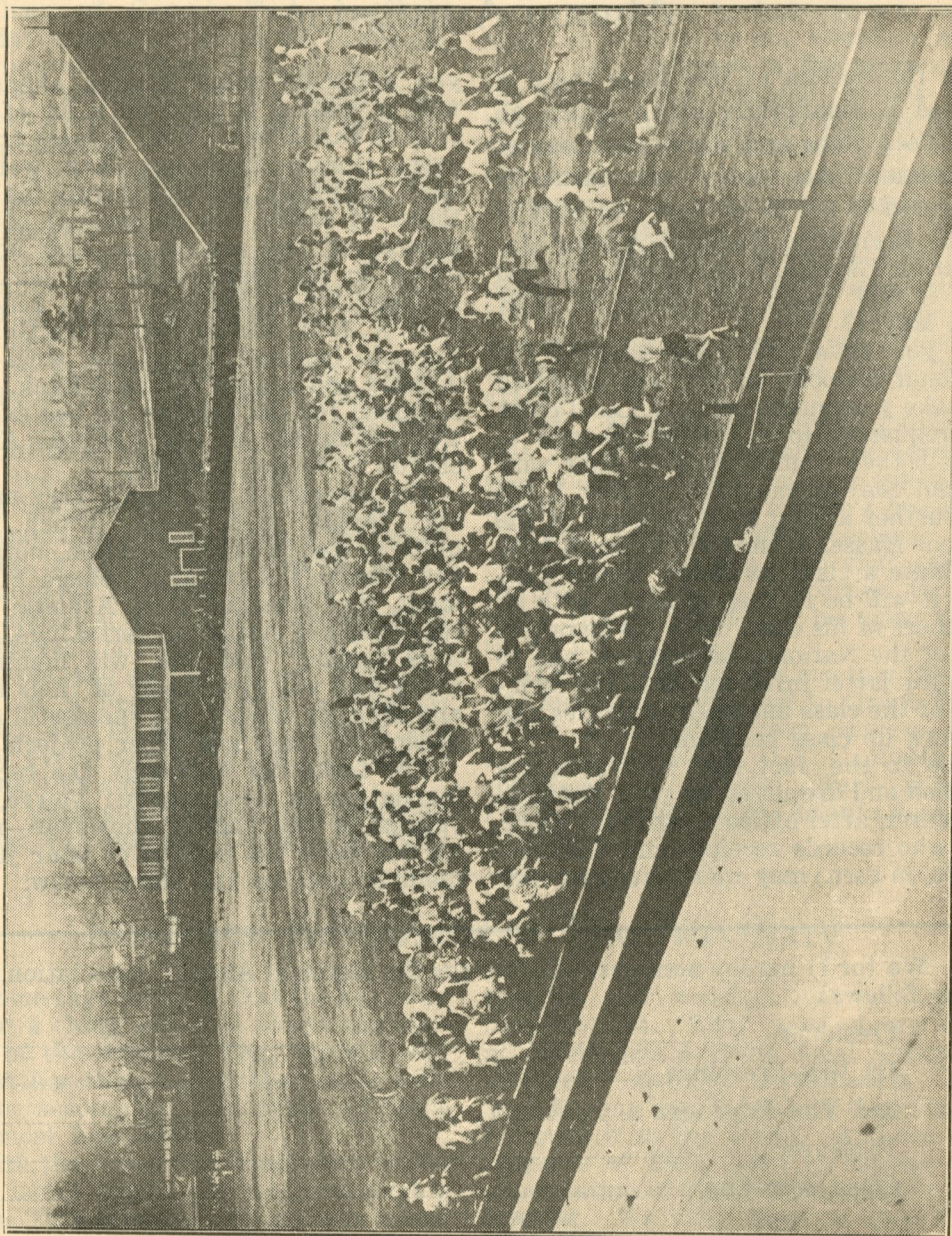

## Annual Cross Country Won By Freshman For First Time In History of Race

Setting a record breaking pace, Herbert Gattis, a freshman, won the annual Tech cross-country race Saturday afternoon, March 14, from a field of over 400 entries. His time for the course was 18 minutes and 22 1-2 seconds. This is 21 1-2 seconds better than the record time set by Barret last year.

Ben Peacock, a junior, was second, and some seventy-five yards behind Gattis; while L. H. Poe and Ed. White followed closely behind Peacock.

The winner was the second runner to leave the field but he soon set a pace that put him far in the lead and kept him there until the finish. Gattis will be awarded a varsity track letter for breaking the record and in addition to this he was given a gold medal and his choice of 124 cakes donated by the friends of Tech. Peacock received a silver medal, while Poe was given a bronze emblem. The first hundred and twenty-four runners received a cake.

## Dr. Durand, Pres. A. S. M. E., Speaks To Students

"Members of the Tech Student Branch of the American Society of Mechanical Engineers were given a rare treat on the morning of March 24, when Dr. H. F. Durand, national president of the society, spoke to them. Dr. Durand, who is Professor of Mechanical Engineering at Stanford University, was in the city for a few days and generously consented to give an address to the local branch of the organization. He spoke before the Atlanta section of the society on the night of March 25.

"In speaking of the work of a student branch, Dr. Durand laid particular emphasis on the necessity for an engineer to be able to speak clearly, and forcibly before a gathering of people. This attitude comes only with practice, and Dr. Durand directed attention to the fact that much valuable experience would be gained by students if they should present original papers before the student branch. He warned against overworking the engineering faculty and prominent local engineers by having them speak too often before the student branch, pointing out that while these talks were valuable, they could not approach student program for individual benefit.

"Dr. Durand was accompanied by Mr. Hartford, assistant executive secretary

of the society, and Colonel Doty, a member of the executive committee. Mr. Hartford in a short talk outlined the relation of the student branch to the national organization and the advantages that accrue to the members of the A. S. M. E. Colonel Doty, who is a member of the Minnesota State Board of Engineering Examiners, spoke next. He said that engineering justly deserved the name of profession, and expressed the belief that character is the foundation of success.

"Mr. Earl F. Scott, prominent consulting engineer of Atlanta, and President Brooks, of the Atlanta Section of the A. S. M. E. were also present and both gave short and interesting talks.

"After the meeting, Dr. Durand and his associates were introduced to President M. L. Brittain and shown about the campus."—Technique.

## More Than Sixty Track Teams To Perform On Grant Field April 18

The Ga. Tech Athletic Association has recently announced that the twenty-four of the leading prep schools in the south have already signified their intentions of sending track teams to the third annual southern relays which will be held on Grant field, April 18, and half that many more are expected to enter before the registration closes.

In addition to these prep and high track teams there are twenty colleges, four junior high and sixteen grammar school teams that have already sent in their entrance blanks.

The prep teams that have announced their intentions of entering are: Tech High of Atlanta, Boys' High of Atlanta, Jackson High, Boaz High of Boaz, Ala.; Savannah High, Marist college, Marietta High, McCallie of Chattanooga, Baylor of Chattanooga, Richmond Academy of Augusta, Georgia Military Academy, Wrens High, Madison High, Piedmont college, Darlington, Gainesville High, Emanuel County High, Berry school of Rome, Simpson High of Birmingham, Athens High, Winder High, Newnan High and Lawrenceville High.

Never before has there been such a gathering of prep school track talent and the records set last year by Baylor, Boys' High and Marietta should be greatly jeopardized. Baylor had a rather

easy time of it and set records in both of the relays for prep schools. Boys' High, with Kontz as its ace, ruled supreme among the high schools.

Tech High did not enter its strongest team on account of the Sewanee prep meet, but this year they will concentrate on the Tech relays. Of the above list of entries only about one-third of them attended previous relays. Practically every strong high school team in the state is entered or is figuring on sending a team. Lanier High, of Macon, and Columbus High, are among those missing but they will probably be heard from later.

Furman, winner of the half-mile class "B" relay for colleges last year, and Sewanee are the latest additions to the colleges sending teams. Twenty colleges are now listed as on the "sure list" while there are several more that are expected to send teams. Every college in the state is sending a team.

A total of sixty-four teams representing grammar schools, junior high schools, high schools, prep schools, colleges and universities have already filled out entry blanks and this number will probably be increased to seventy-five before the entry lists close. These southern relays have had an almost mushroom growth and have increased from eighteen entries in 1923 to the present number.

## First Trans-Oceanic Flight Commanded By Tech Alumnus

While making the flight, the fleet encountered a dense fog over the Azores, and Lieut. Ballenger smashed his machine in landing although escaping uninjured himself. Commander Towers in his machine was missing for three days and taxied in under his own power, half starved and his plane out of commission. Captain Reed, in the third plane, found a hole in the fog, landed safely at the designated port in the Azores and successfully completed the first trans-Atlantic flight to London.

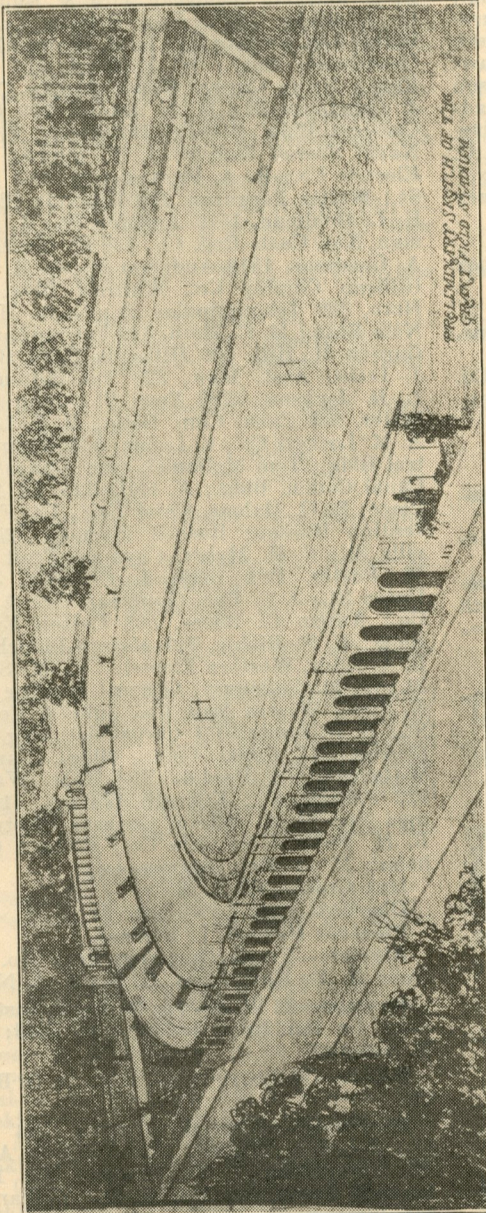

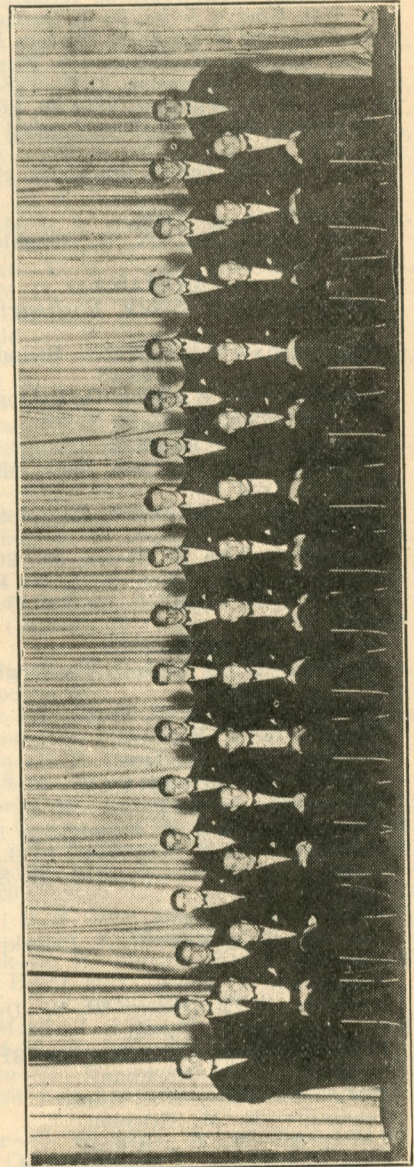

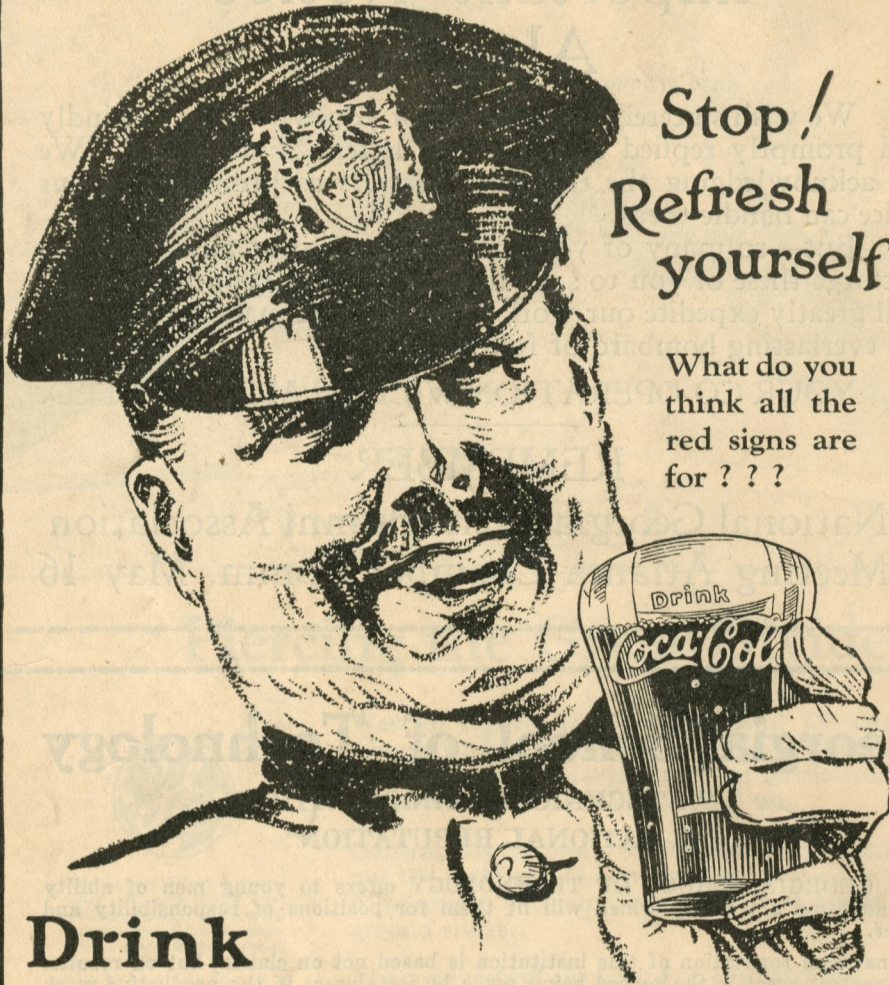
